1. Object of the contract

The object of the contract is to determine the conditions for running and participating in sports and recreation activities in the field of gymnastics and acrobatics (hereinafter referred to as classes)

The classes take place in

The classes do not take place during Christmas break, winter holidays, public holidays and summer holidays.

- 22 June – end of the school year in SK Talent club

2. Payment rules

- 2.1. Parents / guardians commit to pay in advance for each month by the 8th of each month. The fee must be paid before or after classes at SK Talent club in accordance with the applicable price list. 120 PLN per month - classes once a week, 180 PLN classes twice a week, and 220 PLN classes 3 times a week.
- 2.2. The monthly fee is averaged and is identical for each month regardless of holidays and days off.
- 2.3. In the absence of a participant in the classes, the organizer does not refund the unused lessons.
- 2.4. In the event of arrears in payment for more than 5 days without individual arrangements, the participant will be suspended from participation in classes until the payment is made.
- 2.5. If the required fee is not paid by the end of the month to which it relates, the contract will automatically be terminated on the last day of the month.
- 2.6. The invoice for participation in classes will be made once for all months at the end of the school year.

3. Duration of the contract

- 3.1. The contract is concluded for a definite period from 1.10.2017 to 22 June
- 3.2. Termination of the contract before the deadline is possible at the end of the calendar month with a 14-day notice period. The termination requires a written form.
- 3.3. All changes to the contract must be made in writing under pain of being declared null and void.
- 3.4 In the settlement of disputes in matters not covered by the provisions of this contract, the relevant provisions of law shall apply.
- 3.5 The contract was concluded in two identical copies, one for each party.
