

REGULATIONS

1. Participation in classes

Participants of classes organized by the SK Talent Group may only be persons who have accepted these Regulations and have paid fees for the classes, in accordance with the current price list. Monthly fee is a fixed fee for classes and for a place in a group regardless of the number of weeks in a given month. Price list: • 1 class x a week - 120 PLN / month (1 h) • 2 classes x a week - 180 PLN / month (1 h), • 3 classes x a week - 220 PLN / month (1 h)

2. Safety

2.1. The SK Talent subdivision does not insure participants of classes for unfortunate accidents or bear any responsibility for unfortunate accidents or injuries occurring during classes and encourages to self-insurance.

2.2. SK Talent is not responsible for the property of class participants. In the event of a possible theft, the participant or his representative is obliged to report this fact to the police. Classes participants should inform the reception about the theft as soon as it is discovered.

2.3. It is prohibited to stay in the gym without the knowledge and consent of the instructor. When you are in the hall, you must obey the instructions of the instructor. The participant or his legal guardian is liable for damage caused as a result of the participant's failure by following the instructor's orders. Responsibility for removing damages made by the participant of the classes is borne by the participant or his legal guardian.

2.4. For hygiene and safety reasons, it is forbidden to bring food and hot drinks to the gym. It is allowed to bring only water in a plastic and tight container.

2.5 Persons staying in the gym are required to comply with the health and safety regulations and instructions of the representatives of the SK Talent Group and to maintain cleanliness, respect for property and other participants of the classes.

2.6. People who are waiting for classes have to stay in designated places, so as not to disturb the order.

2.7. It is forbidden to smoke, bring or consume alcoholic beverages and intoxicants. It is forbidden to bring animals, bicycles and other objects that may cause danger to the participants of the classes.

3. Organizational matters

3.1. Sk Talent requires a sportswear: t-shirt, shorts, leggings, socks or ballet shoes.

3.2. Before entering the gym it is obligatory to change shoes. The instructor has the right not to let people inside with footwear that makes the floor dirty or causing damage to it.

3.3 Girls must tighten the hair with an elastic band and remove all jewellery (including glasses).

3.4. Only those who are on the list of participants of the given classes can stay in the gym during the classes.

3.5. For the comfort of the class participants, parents and other accompanying persons should not be in the gym.

3.6 The number of people in groups is limited. If the group is full, the list will be closed. In the case when too few people are attending the classes of the group, we reserve ourselves the right to join two or more groups. In this case, the groups will be combined taking into account the already existing skills of the enrolled participants and their age. If the changes related to the merger will interfere with the time availability of the class

participant and no classes will be suitable for the participant, SK Talent undertakes to transfer the unused payment made by the participant to the payment of other classes or to return it.

3.7. SK Talent reserves the right to dissolve the group in the following cases: a / lack of a sufficient number of people willing to participate in a given class b / decrease of the number of participants during the classes, and the merger of the groups referred to in the preceding paragraph did not take place - in such cases there will be a proportional refund of the fee paid.

3.8. In the case of illness or disability of the instructor, SK Talent has the right to designate another instructor for the classes without any information of the participants in advance.

3.9. In random situations, SK Talent has the right to cancel classes. They will take place on a different date in agreement with the participants.

3.10 If the participant cannot take part in the classes, the unused part of the fee will be counted towards other classes or refunded.

3.11. Talent Group has the right to change the date of the class schedule and group instructor in the new term.

4. Personal data protection

4.1. The administrator of personal data is only the SK Talent Group. The participant agrees to the processing of personal data by the SK Talent Group for purposes related to the organization of classes. The participant has the right to access their personal data at any time and request their correction, modification or deletion.

5. General matters

Persons who grossly fail to comply with the SK Talent Group Regulations may be removed from the list of participants. The deletion of the participant is tantamount to resigning from the classes, without the right to refund fees provided by the participant. The Regulations are available at <http://sk-talent.pl/>. Sk Talent reserves the right to introduce changes to the regulations in a written form, an appropriate annex and announcements. The Regulations come into force on 1st October, 2017.
